Guest and Story Release Agreement – No One Is Normal

1. Permission to Record and Use Voice, Likeness, and Story

I understand and agree that Brad H. Hill (“Producer”), Brad H. Hill Media Group, the No One Is Normal podcast (“Program”), and associated websites (NoOnelsNormal.co and BradHHill.com) may record my voice, likeness, image, and statements in audio, video, and written form. These recordings may be captured in person or through remote technology.

2. Permission to Use My Submitted Story

I grant Producer the right to use my story and any information I share in the specific podcast episode featuring my appearance and promotional use directly connected to that episode, including use on the podcast website, social media, short clips, trailers, thumbnails, quote graphics, and podcast advertising for the episode or the No One Is Normal podcast. I understand that my story may be combined with other stories, edited for length and clarity, and used for the limited purposes stated above. I understand that my interview and story may be publicly distributed permanently.

3. Editing Rights

I understand that the Producer may edit, adapt, summarize, rearrange, or otherwise modify my recorded or submitted material for clarity, length, and impact, while maintaining the core meaning of what I shared. I waive any right to review or approve the final edited version before it is used. I understand that I may request in writing that my participation be withdrawn before any public release of the recording, and I acknowledge that the Producer has sole discretion to grant or deny such a request. Once the recording or content has been publicly released, withdrawal is not possible.

4. AI Consent

I allow my story, voice, and likeness to be processed with AI tools for purposes such as transcription, editing, noise reduction, content tagging, and formatting for audio, video, or written publication.

5. Rights Granted

I grant Producer a worldwide, royalty-free license to use, reproduce, distribute, display, perform, publish, adapt, and create derivative works from my interview, story, and recorded materials (including audio, video, still images, thumbnails, and screenshots from the recording) solely for the podcast episode featuring my appearance and promotional use directly connected to that episode, including podcasts, websites, social media, promotional clips, trailers, thumbnails, quote graphics, and podcast advertising for the episode or the No One Is Normal podcast. **This license is not sublicensable and not transferable. This agreement does not grant permission for books, branded merchandise, commercial products, paid programs, licensing deals, or unrelated projects without my separate written permission. I do not waive moral rights or similar rights of attribution or integrity in the Content to the extent permitted by law.** I understand that I will not have any ownership interest in the final products created from my appearance or story.

6. Representations and Warranties

I confirm that:

- The story and material I share are based on my own experiences, or I have permission to share them.
- To the best of my knowledge, my statements are truthful and are not intended to knowingly defame, harass, or unlawfully infringe the privacy or rights of any other person or organization.
- I will not knowingly disclose confidential information I am legally barred from sharing.

I agree to notify Producer if I become aware that anything I shared may cause a legal or privacy issue.

7. No Compensation

I understand that I am participating voluntarily and that I will not receive payment, royalties, or any other form of compensation for the recording, use, or reuse of my appearance or story.

8. Release of Liability

I release and discharge Brad H. Hill, Brad H. Hill Media Group, Brad H. Hill Publishing, the No One Is Normal podcast, NoOnelsNormal.co, and BradHHill.com, along with their employees, contractors, partners, and assigns, from any and all claims, demands, or causes of action arising out of or related to the recording, use, editing, distribution, or publication of my voice, likeness, and story, including any claims for invasion of privacy, defamation, or rights of publicity.

9. Governing Law and Entire Agreement

This agreement is governed by the laws of the State of Wisconsin, without regard to conflict-of-law principles. Any disputes arising from this agreement will be handled in the state or federal courts located in Wisconsin.

This document is the complete agreement between myself and Producer regarding my appearance and story. Any changes must be made in writing and signed by both parties.

10. Indemnification

I agree to indemnify and hold harmless Brad H. Hill, Brad H. Hill Media Group, Brad H. Hill Publishing, the No One Is Normal podcast, NoOnelsNormal.co, BradHHill.com, and their officers, employees, contractors, licensees, and assigns from any and all claims, damages,
